4. TRANSLATION CONTRACT – Out of his willingness and hard work, a Kenyan resident even acquired a Swahili translation contract for Ababu, at a time when he needed cash the most and when he had be thrown out not only by his hosts, but also some of his own relatives. The contract netted \$3751.86 for Ababu Namwamba. No words of thanks in return.

Generosity and hospitality are well known and regarded things amongst Kenyans in the Diaspora and this can be attested by many high ranking Kenyan government officials who have visited the region. For those who have visited in the past – thank you for your visits, for those who will be visiting for the first time- you are most welcome.
